What is Stand Up-Stand Out?

When we seek philanthropic support, a commonly asked question is "What is your level of employee support?" Your level of employee engagement directly impacts our ability to grow by impacting our ability to secure philanthropic support from outside organizations.
- You can take pride in knowing that your gift helps us build new buildings, attract the best and brightest faculty and students, and support patient care. It takes all of us to advance our mission of better health care for everyone.

What is our campaign goal?

I want to give, but giving all at once may be difficult. How can I spread out my gift?

We think the easiest way to give is through payroll deduction. Just indicate on the enclosed form the total annual gift you would like deducted from your paycheck; payments will be deducted each pay period.

Take the Hour of Power Challenge

This year, we're also issuing a special "Hour of Power" challenge: We're encouraging all employees to donate at least one hour of their pay per month. To determine your hourly pay, refer to your last pay slip. If you are a full-time exempt employee, take your pretax annual salary and divide by 2,080.
